Minutes for the Annual Parish Council Meeting of Ludford Parish Council held at the Ludlow Mascall Centre, Lower Galdeford Ludlow on Monday 13th May 2019 This meeting began at 19.25 following the Annual Meeting of the Parish.

Several residents from Lower Barns Road spoke out about their concerns for Planning permission 19/01743/FUL. The residents at the meeting fully object to the planning permission for 2 new properties. The Chair confirmed that the matter would be discussed by Councillors later on in the agenda.

Cllr Liddle confirmed that he had investigated a company known as 'Heals' who had contacted the Council directly offering their services, and he had found that the company were unsuitable due to representing Crest Nicholson Homes and should not be approached. He also confirmed that he had been investigating Crest Nicholson Homes and their use of Management companies on their new developments to arrange and organise communal areas including attenuation ponds. He expressed grave concerns and commented that Shropshire Council should be mindful of their actions when arranging future S106 agreements.

 Cllr Paul Knill reported from in and out of Ludlow – addition of a bus stop in Corve Street
 Cllr Jeff Garraway – reported on planning matters at Rocks Green confirming that bird netting had been removed and that work was being undertaken under the supervision of a scientist, however only 1m of a permitted 10m strip had been touched before work was halted.
 Cllr Imogen Liddle reported on the Emergency Plan – McCartneys had confirmed that they would facilitate an Emergency Centre (all to be confirmed)
- 19/12 The Ludford Bone Bed - Cllr Liddle confirmed that the Rugby Club were placing spikes with notices on into the bone bed and that this must be stopped. Clerk to write to the Rugby Club.
